(The condensed version)



I have been using my construction background as a platform to develop a Real Estate Business, and have moved to the Windermere Real Estate Brokerage in Shoreline since 2008.



Beware of bankrupt retailers bearing discounts

You may have seen this recently: A retail store goes out of business and suddenly becomes the most popular place in town. With huge advertised savings (“Entire store up to 70% off!”), it’s Black Friday Part Two. Here’s the question: If you buy there, are you really getting a bargain?

Deals may be only skin deep

Those deep discounts may be purely cosmetic. Bankrupt stores will often significantly raise prices before the fire sale begins. Bargain hunters can end up paying more than they would have before the liquidation. Here’s a recent example. A bankrupt store was selling a specific model of TV for \$2,520 when it was available at other retailers for \$1,975. The store took their advertised discount (10%) off of the manufacturer’s suggested retail price of \$2,800, rather than their own pre-sale price.

Beware the liquidator

The liquidating store may not be the store you knew. A liquidation company usually takes over for the bankruptcy sale. They’re experts at extracting value from a dying retailer to repay creditors. By advertising big discounts, liquidators create a “beat the rush” mentality early in the sale. This allows them to maximize profit from customers who let enthusiasm trump caution.

What you can do: Shop defensively

Fortunately, there are some simple steps you can follow to make sure you get your money’s worth:

- **Compare prices online.** The Internet makes it easy to check out a supposed bargain. Just search for your potential purchase on a competitor’s website. Or you can use a price search engine like [Google Product Search*](#) or [PriceGrabber*](#).
- **Pay attention to model numbers.** Is the store selling last year’s products at this year’s prices?
- **Inspect the product.** The bankrupt store won’t take returns. If something comes out of the packaging broken, your only recourse is the manufacturer’s warranty. That can be highly inconvenient if you’re required, for instance, to ship a big-screen TV back to the factory.
- **Avoid products you can’t find elsewhere.** “Everything must go” applies to inventory that’s been in the back for years. If you see a huge stack of a product, there’s probably a reason the store still has it when no one else does.
- **Keep your cool.** Avoid the impulse buying the liquidator is counting on. If you didn’t need a product when the store was in business, you probably don’t need it now.
- **Stick to basics.** Simple products are more likely to be bargains. You don’t need the Internet to tell if you’re getting a deal on some towels or a desk calendar. Big-ticket items are usually the biggest risk.

Remember, the store probably didn’t go under by selling superior products at great prices. You’re dealing with professionals trying to squeeze the last bit of value from a failed business. Shop defensively, and you can easily avoid overpaying for something no one wanted. (extracted from Vanguard)
